Orientation program is organised every year for newly admitted students to make them aware of their course content. This year due to Covid-19 situation online orientation programs organized by the faculty members of all departments. 3. Routine Committee of the college prepares the class routine and circulate it to the different department . Routine is prepared strictly in accordance to the number of credit points and number of classes (for CBCS / Non CBCS Courses) mentioned in the prescribe syllabus. As per the Covid-19 SOP framed by the state govt. online & offline classes were conducted accordingly on the basis of separate class routine. 4. Based of the master routine all department prepares own departmental routine and allotted classes to each teacher. 5. Along with the traditional chalk and talk mention teachers often use power-point presentation in the digital class room for offline students during the teaching time. 6. Class Test /Surprise Test and seminars / Group Discussion etc. are held after Completion of session of the syllabus. 7. Tutorial classes are held in some department. After 2nd September 2020 onward as par SOP for conducting classes. 8. Field Tours are organized by some department like History, Education, Assamese before lock-down for Covid-19 pandemic in India. 9. Due to Covid-19 situation maximum numbers of students opted online classes and it was conducted through Google meet, Zoom Meeting, Cisco-Web, WhatsApp group etc.
